



Statement by worldwide organizations in the protection of the fourth amendment of the Hungarian Constitution

The signing entities below are concerned about the heavy attacks from various EU fora that Hungary is facing due to its fourth amendment of its new Constitution, protecting the family and marriage as the union between a man and a woman.

We acknowledge that these attacks are based on misconceptions and ideological manipulation and that the Constitution of Hungary is based on the fundamental norms of democracy, rule of law and human rights. We recognize that this Constitution reflects and respects European constitutional practices and it can serve as a model for many European nations and politicians especially due to the severe economic, moral and demographic crisis that most of the countries find themselves in.

We thus call for respect of the sovereignty of the Hungarian people and we invite all organizations and people who feel responsible for the protection of life and the institution of the family to stand up for Hungary.
